Change in GST rate from 7% to 8% with effect from 1 Jan 2023

Thank you for your invaluable support for InteReq.

The InteReq legal requisition and processing fees will be amended to reflect the new fees payable arising from the GST increase of 7% to 8%.

The GST-inclusive agency fees will remain unchanged in 2023 as the agencies will be absorbing the 1% increase in GST (7% to 8%) from 1 January 2023 to 31 Dec 2023. An adjustment has been made to temporarily reduce Agencies' GST-exclusive fees so that the total amount inclusive of GST remains unchanged in 2023.

Please also take note that InteReq will cease receiving requisitions from Friday, 30th December 2022 (1700hrs) to Saturday 31st Dec (2359hrs) as we adjust the system to take in these changes. You can still continue to log in to InteReq during this period to view or retrieve replies as per normal.

The service will be available to accept submissions from Sunday 1 Jan 2023 (0000 hrs).

A more detailed breakdown of the fee structure is appended in **Annex A**.
